Summary Report

Introduction

This report has been prepared for the Abbotskerswell Neighbourhood Plan Steering Group. Its purpose is to provide the Group with the percentages and an initial analysis of the response to the 2015 Neighbourhood Plan Community Survey. The Survey was opened and questionnaires distributed to everyone resident in the Parish of Abbotskerswell at the beginning of March 2015.

Questionnaire Design and Distribution

The purpose of the Community Survey was to:

- Fill gaps in our knowledge and understanding of community issues, particularly as they may affect neighbourhood planning
- Increase comprehension and measure community opinion on key local and neighbourhood planning matters
- Test community support and reaction to recent planning and development issues
- Establish a broader base of community interest and engagement in neighbourhood planning

The final version of the questionnaire used can be found in the appendix to this report. The questionnaire comprised some 30 questions in total. It was approved for printing by the Neighbourhood Plan Steering Group in January 2015.

The questionnaire was delivered to every dwelling in the Parish of Abbotskerswell along with the March 2015 edition of the parish magazine 'AbbTalk'. People were asked to complete the questionnaire by March 31st. A freepost envelope was provided for ease of return; or if more convenient, questionnaires could be dropped off at the Model Stores. The questionnaire was also made available via the website. Those that completed an electronic version of it could return it by email to abbplan@gmail.com. Making it available online was the main mechanism by which other individuals within a household could have their own questionnaire.

On the 31st March 2015 110 completed questionnaires had been returned. Given that the adult (over 16) population of the Parish is around 1,300, the Steering Group decided to extend the deadline and issue a prompt to ask people to return them via 'Abbtalk'. A reminder was put on the front cover of the April 2015 edition of 'AbbTalk' with a last date for return being set for 12th April 2015.

On the 18th May 2015 it was reported to the Abbotskerswell Parish Council that *"a total of 160 questionnaires have been received and are ready to be analysed"*¹.

Response and Bias

At the end of August 2015 the total number of completed questionnaires received and transcribed; and subsequently used as the basis of analysis for this report was 167. This is approximately 12.8% of the adult population.

The initial tables below present a demographic and residential summary of the respondents to the Community Survey. It is clear that the younger members of the community are under-represented in the response. Only three of the respondents to the survey are under 25. This should be remembered when interpreting and analysing the responses.

Abbotskerswell Today

The questionnaire set out to explore how local people viewed various aspects of the Parish in 2015. Housing, job opportunities and leisure facilities were each singled out as being an ‘area of interest’ that the Neighbourhood Plan may be able to have an effect upon.

The response table below shows that people are generally satisfied with housing and leisure provision. Around two-thirds of respondents rate local housing (64.4%) and leisure (69.2%) as either good or excellent. Most of the other respondents rate housing and leisure provision as at least ‘average’; few think that either of them should be rated as poor.

Local job opportunities however are rated either good or excellent by only 10% of respondents. Almost half of respondents (48%) rate local job opportunities as only average whilst 42% regard them as either poor or inadequate. (We find that only 13% of the 2015 Survey’s respondents actually work in the Parish.)

The Community Survey 2015 was used to explore which of the local facilities are most used by local people. The table below shows the response in order of usage. Clearly many of the community facilities play a significant part in the life of local people. Most people say they use the shop. Around four in five respondents use the local pub and almost two-thirds of respondents report using the village hall. The church still features in the life of almost half (48%) of respondents.

Not unexpectedly, 89% of respondents also report going outside the Parish to use other facilities.

The extent of usage of local facilities is confirmed in the table below. This table also indicates that over a third (36%) of respondents are actively involved in a local community group. Whilst this is a minority, just over 80% of all respondents do believe that the sense of community prevailing in Abbotskerswell in 2015 is either strong or very strong.

The Environment

The Survey asked local people how they rated the environment of the Parish in 2015. Nearly 90% regard the local environment as good or excellent.

People were asked what they thought was particularly good or bad about the environment in the Parish. An open question about good and bad naturally attracted a wide range of comments, many of which were not directly related to the environment.

High on the list of good things about the environment are: the positive impact of surrounding countryside; the quality of the built environment; the fact that Abbotskerswell has no through traffic; and the quality of the green areas that local people have access to. The fact that it appears clean and tidy is remarked upon by several people. Although just as many people complain under the 'bad things' about: the state of the environment; about litter and fly tipping; and about the condition of the footpaths. Irresponsible dog owners also get a lot of criticism. The negative impact and effect of parking and traffic is also regularly commented upon.

People were asked to state the three best things about the Parish. The table overleaf lists everything that was mentioned in people's top three. It is clear that people take much pride in their community and the rural area in which they live. The shop and its staff come in for a great deal of praise. The school, the pub and the church are all highly regarded.

People were also asked if they could change one thing about the Parish, “*what would it be*”? The response to this question is set out on page 21 and contributes to the overall conclusions drawn from the Community Survey and its analysis.

Housing

As recorded on page 2 of this report, many (64% of) local people agree that the 'quality' of the local housing stock is good or better. However there is far less agreement as to how Abbotskerswell should grow and what housing, if any, is needed. Over 70% of respondents are not persuaded that there is a need for more general 'market' housing; and the community is completely divided over the need for affordable housing.

People were asked where they would prefer to see any new housing built. A number of opinions were expressed in response. Several responses were more about the general approach to site selection e.g. small infill, or brownfield sites, shared amongst the settlements etc. Although there is no discernible preferred 'strategy' to be gleaned from these responses.

The most often named locations for new housing development are Manor Road, Water Mota and Butchers Arms. Again there is no clear favourite.

It seems clear that the 'issue' of further housing development in the Parish and its preferred location needs to be the subject of further discussion and consultation.

Only 30% of respondents to the Survey offered a number for the affordable homes which they think is appropriate to be built in the Parish over the next 15 years. Most people think that no more than 20 is an appropriate scale of new housing development.

Employment

It is clear that the availability of local job opportunities is not regarded as 'good' by most local residents, although that is not necessarily seen to be a problem. Less than half of 2015 Survey's respondents (46%) feel that there is a need to create more local jobs and just over 60% of people do not support the idea of more business development taking place in the Parish.

The 2015 Survey asked those that are supportive of new business development where they think it might take place. A number of locations get a mention from the 33 respondents that answered this question. Just over a third believe that any new business development should be focussed on the current industrial estate area. As to the type of new business people think is needed, the most often used comment is “small”. There seems to be no clear preference, and there is quite a wide spread of business types amongst the suggestions received from the 37 people that answered the question.

In the opinion of most (95%) of the respondents to the 2015 Survey, should new business development take place, businesses should be provided with sufficient off-road parking for their staff needs, so as not to add to the parking problems of the area.

Broadband speeds locally have been an issue and 92% of respondents recognise the importance of super-fast broadband to those running a local business.

Transport

The most common form of travel, even for journeys within the Parish, is the private motor car. Almost half (46%) of all local journeys reported by respondents are undertaken by car. Just over a third of local trips are made on foot. The bus serves about 10% of the local trips. The bicycle and motor cycle do not figure much as preferred modes of transport amongst the respondents to the 2015 Survey.

We have been aware from the 2011 Census that access to a car is relatively high. Only 7% of households in Abbotskerswell do not have daily access to a private motor car. Over 50% of households in the Parish have more than one car at their disposal. It should be noted from the table below that car ownership profile of the 2015 Survey respondents is similar to the 2011 Census. There should be little doubt therefore about the validity of the community's opinions expressed via the 2015 Survey on road and travel matters.

The questionnaire asked people approximately how many miles they travelled to work each day. The chart shows the response from the 59 respondents that did travel and also answered the question.



70 people state on what basis they would consider using public transport as a preferred mode of travel. A third of these respondents say that nothing would encourage them to use the bus. Amongst those that might be tempted to use the bus in future, the need for greater “frequency” and more “convenience” (of timetabling in particular) are most often mentioned.

There is much more agreement as to whether parking locally is a problem. 82% of respondents believe that there is a local parking problem. Several locations are cited by respondents where, in their opinion, car parking constitutes a problem at times.

How parking problems can be solved is not something on which the community seems to agree on. Less than half of respondents think that parking restrictions should be introduced. This view is clearly reflected in the response to the various parking measures proffered in the questionnaire. 57% of all respondents are opposed to residents' parking areas; 62% are opposed to additional yellow lines; and 70% are opposed to introducing restricted parking periods.

On the more general matter of traffic and how to reduce speed in parts of the Parish, a large majority of respondents (88%) are in favour of introducing a 20 mph speed limit; but over 60% are not in favour of traffic calming measures.

There is little evidence, in the 2015 Survey's response, of a great deal of regular cycle use by local people. Moreover, almost two thirds of respondents (62%) disagreed with the proposition that a dedicated cycle path would encourage many more people to use a bike to get to work as an alternative to motor transport.

People were asked to suggest potential routes and destinations for a cycleway. The following comment seems to sum up the view of many. *"The problem with cycling from Abbotskerswell is that all 5 roads go up hill."* There is much scepticism about the value and demand for a local cycle route. Despite this a number of suggestions (overleaf) were made as to possible locations and destinations:

Open Space

It seems that around four out of five local people think that there is sufficient public open space in the Parish. Moreover, almost everybody that answered the questionnaire (98%) believes that the public areas of the Parish are well looked after.

Those people that felt that the current amount of public open space was less than sufficient were asked to indicate what sort of additional open space they would like to see and where this might be located. Conservation Area

Almost everybody (98%) agrees that the conservation areas in the Parish are important and should be protected. Three quarters of the respondents think more should be done to enhance the character of the conservation areas. There is also a majority (55%) in favour of extending the boundaries of the conservation area and a very large expression of support (96%) for putting in place policies covering the built environment outside of the conservation areas that impose standards of development, redevelopment or conversions, presumably to ensure that the overall character of the area is not harmed. Measures to conserve energy and extend the use of renewable energy within the conservation area and beyond however do seem to be acceptable in principle to a relatively large majority of people (85%).

Recreation

85% of local adults believe that there are sufficient recreational/entertainment facilities in the Parish. The Survey asked specifically whether it is thought that there is sufficient elderly persons' exercise equipment. More than four in five person (83%) say there is. An even higher proportion of adults (94%) think there is sufficient play equipment for children.

The Survey asked those who thought facilities were lacking, what sort of facilities they would like to see. The most remarkable thing about the response is that whilst there is a lengthy list of suggestions, few of them are made by more than one person. Of the 23 relevant suggestions received only "*more for the teenagers*", "*re-open the Butchers Arms*", "*a film club*" and "*a swimming pool*" are suggested by two or more people. The other suggestions received are:

- Bowls club
- Communal garden
- Dog walking area
- Modernise village hall
- Public toilets
- Running track
- Sports club

Few people have commented on the need to up-grade or replace existing children's play equipment in the Parish. Four respondents say that the existing equipment needs up-grading. Three persons say that there should be more equipment for older children; and a skate ramp is suggested by one person. Three of the respondents cite Ipplepen Park as a good example of the new kind of children's play area and equipment that Abbotskerswell should now have.

The need for additional recreation facilities for the senior members of the community is not an issue for most respondents to the Survey. Over 80% believe that current exercise opportunities and facilities are adequate. Those with thoughts about additional opportunities suggest there should be more walking routes with benches (5 persons suggest this); indoor gym equipment (3 persons); an outdoor exercise trail (2 persons); and an all-weather bike track (1 person).

Community Services

Local school provision is regarded as satisfactory by most people. Only the further-education opportunities are not rated highly; 55% say they think that local provision is not adequate.

The Survey asked people to take an over-view of service provision and, apart from education and health, say whether they thought that “*all age groups are properly catered for in the Parish, for example the youth and the elderly*”. Almost 70% of respondents said “*yes*”. Those that answered in the negative were asked to explain what, in the way of facilities, they thought should be provided. Because of the leading nature of the question most of the comments relate young people or the elderly. 33 respondents confirm that they feel there is more needed for young people. A youth club is favoured by many; but for some it is not the answer. There is concern about the cost of providing and managing such a facility. Some people think that local young people would re-act more positively to club-based activities and events rather than facilities.

Sustainability

The availability of services is just one of the factors that people had to take into account when considering their answer to the question: "do you consider the Parish to be sustainable at present?" 85% believe that Abbotskerswell is a sustainable community in 2015.

Renewable energy was the subject of the final question on the questionnaire. In terms of protecting natural resources and encouraging the use of renewable energy in the Parish, the community does not agree that it should be any more pro-active. Only 38% of people were in favour of encouraging “renewable sources of energy”.

Those that are in favour of encouraging renewable energy development were asked to explain how this “might be achieved”. A wide range of suggestions have been made. Clearly the most favoured ‘solution’ is the installation of solar panels on the roofs of all new buildings and encouraging local people to install panels on existing roofs where appropriate.

And Finally...

People were given the opportunity for any final comment after completing the questionnaire. 39 respondents decided to do so.

Not surprisingly many of them took the opportunity to repeat or re-inforce a point or two that they had made previously in the questionnaire. The text box overleaf attempts to capture the essential point from each of the 'any other comments' received. Taken together they probably encapsulate the main themes and messages coming from the community of Abbotskerswell parish in 2015.

The Community Survey of 2015 has given local people an opportunity to express their views and aspirations. It has encouraged them to feel that their views count and will influence policy development for the Abbotskerswell Neighbourhood Plan.

The full set of 'final comments' do make an interesting read. They also demonstrate the extent to which people care about their home, their local area and the community they are part of. It is recommended that all members of the Neighbourhood Plan Steering Group read through them in full.

- *parked vehicles are making it DANGEROUS especially for the young and elderly*
- *should be proactive in supporting young families and their educational needs and provide a free school bus*
- *The industrial estate looks 'tatty'*
- *Priory Road path has a very long, unkempt private wall*
- *strict development guidelines must be adhered to as the village could be in danger of being swamped*
- *shortage of small 1 and 2 bedroom property in the village - this is needed for the young starting off*
- *All residential development, especially affordable housing, should have a high energy efficiency spec. and space for two cars*
- *important for street lighting to be on during the hours of 11-3 am*
- *our main focus is conservation and not development*
- *one of the few thriving rural communities left, let's keep it like it*
- *solar panels are ugly and spoil the look of a lovely village*
- *welcome to Abbotskerswell signs are old and dirty*
- *Is a new "housing estate" behind Manor Road really necessary?*
- *only areas which stand out to me for redevelopment are The Butchers Pub and garden*
- *school really needs to develop old swimming pool site*
- *An occasional "work party" of villagers who plant bulbs and plants in communal areas might be a good idea*
- *feel very strongly about keeping Abbotskerswell village very separate from Newton Abbot*
- *no need for further building in the village except perhaps for a few affordable homes*
- *The village needs an influx of young people*
- *Preserve and enhance the character of the village*
- *Parking and speeding are serious problems*
- *Need to balance level of further development with the threshold for the need for additional facilities*

Conclusions

There is much to be learnt from the 2015 Community Survey that should influence and inform the development of the Abbotskerswell Neighbourhood Plan. On many topics the collective community opinion seems quite clear. For other topics it is less so. The diagram below attempts to illustrate the extent of convergence or divergence of local opinion on the various matters raised in the questionnaire. The Neighbourhood Plan is about shaping future development. There is obviously some disagreement in Abbotskerswell on several aspects of future development and growth. These are matters that will require further debate within the community before policies can be drawn up.



Future 'debate' and development of the Neighbourhood Plan should also acknowledge what local people's priorities are. The table overleaf provides a summary analysis of the question about "what would you change".

Having analysed the response to all the questions it is felt that the table overleaf is a reasonable representation of current concerns and priorities i.e. traffic and parking 'controls' are needed; local services and facilities should be protected and improved; any new development should be sensitively located and designed; the amenity of the village should be enhanced; local people should take more responsibility; the area has a special character lets ensure that is protected. A community agenda is emerging.

General notes on Neighbourhood Planning:

1. The Neighbourhood Plan will set out where new development will go if any, what kind of development it will be, what sort of social and leisure facilities are needed to make Abbotskerswell an even better place to live and work, and how to ensure a sustainable environment in which both people and wildlife can flourish.
2. Neighbourhood Plans provide local communities with the means to make plans for their own areas. Local people can not only write their own Neighbourhood Plans but they also decide whether the plan should be adopted through a local referendum vote.
3. Before any planning proposals are made the Neighbourhood Planning Group needs to find out what the local community thinks about our Parish. To do this the Group wants to hear from as wide a range of local people as possible - residents, businesses, shoppers, young people, older people, community groups, service providers, and other stakeholders.

Specific issues relating to Abbotskerswell:

1. In our case, neighbourhood means the Parish of Abbotskerswell as outlined in blue on the map above, which includes Two Mile Oak and Stoneyhill, as well as the village of Abbotskerswell. This questionnaire is being distributed to all households in the Parish businesses and other organisations.
2. The Teignbridge Local Plan was approved in May 2014 and our Neighbourhood Plan has to comply with the key strategic policies in that Plan. The Local Plan was challenged in the High Court by the Parish Council and others over the proposed development of Wolborough and its impact on an area of special conservation. The challenge was dismissed and, although this decision is under review by the Parish Council at present, this means that there will be a significant development on our door step, part of which will fall within our Parish boundary.

The Neighbourhood Planning Group:

This Group was set up a year ago by the Parish Council which is responsible for producing the Neighbourhood Plan. It consists of 7 local people, 3 Parish Councillors and 4 others representing the wider community.

Following the Community Workshop held in June 2014, 7 other people volunteered to join the Group when the detailed work on the production of the plan starts. This has now happened but further volunteers will be welcome.

The Questionnaire:

Can you spend 20 minutes or so answering a few questions to make sure you have your say over the future of our Parish? ***Please do not feel that you have to answer all the questions.***

This is the second stage in the process following the Workshop held last June, and there will still be further opportunities to comment on the draft Plan. The questionnaire is in two parts. The first is a general questionnaire designed to capture your overall views about the place in which we live. The second part has been derived from the analysis of the responses made to the Workshop in June and is more specifically related to the issues facing the Parish.

Please note, although one questionnaire is being delivered to each household, business and organisation, individuals can obtain further questionnaires from the Model Stores where people with different views want to express them. 
